



WENT TO SAN FRAN MISSION AND REGGED FOR SCHOOL CONTEST, GOT 1000 INVOICED THERE, WHICH WAS NOT VERY GOOD. HE CLOSED TO HELP RAISE MONEY FOR AND PUT ON THE EVENT. SHE HAS A FAST TRACK OF PUTTING ON MAJOR SUCCESSFUL EVENTS WITH AND IS HAPPY TO BE WORKING WITH HER. THE CF IS 75% IN PT. NEXT IS PUTTING THE ADDRESSO IN PT.
