RE: 1985 Battlefield Earth Calendar

Dear Mr. Hubbard,

The following will constitute the agreement between Bridge Publications, Inc. ("BPI") and L. Ron Hubbard ("LRH"):

1. LRH agrees to supply 13 illustrations for the calendar. All costs relating to the acquisition of these rights are payable by LRH.

2. Bridge will undertake the manufacture, distribution and sale of the calendars. Bridge shall use its best efforts to promote and procure maximum sales of the calendars.

3. In consideration of LRH's consent to the aforementioned, BPI agrees to pay LRH as follows:

a) Bridge shall pay \$11,000.00 to LRH on execution of this agreement in consideration of this grant of rights from LRH. This payment is not an advance on royalties and is not repayable by LRH.

b) Bridge shall pay LRH the following royalties:

(i) 4% on the first 10,000 calendars sold.

(ii) 6% on the next 20,000 calendars sold.

(iii) 8% on all calendars sold in excess of 30,000.


4. Bridge shall prepare statements accounting for all payments due LRH under this agreement for each quarter ending 31 March, 30 June, 30 September and 31 December. Payments due LRH from Bridge shall be paid weekly and shall be accompanied by an informal statement indicating the basis for payment.

5. The format, style and composition of the text, graphic material and captions of each edition of the calendar shall be determined by BPI with LRH's written consent.





We acknowledge that the rights to sell these artist signed calendars is not included in our agreement to produce and sell the 1985 Battlefield Earth calendar.



RE: 1986 Mission Earth Calendar

Dear Mr Hubbard,

The following will constitute the agreement between Bridge Publications Inc ("BPI") and L. Ron Hubbard ("LRH"):

1. LRH grants the use of 13 illustrations for the 1986 Mission Earth calendar. All other rights are reserved unto LRH. All costs relating to the acquisition of these rights from the artists are payable by LRH. Each copyright shall be secured in LRH's name.

2. BPI will undertake the manufacture, distribution and sale of the calendars. BPI shall use its best efforts to promote and procure maximum sales of the calendars.

3. In consideration of LRH's consent to the aforementioned, BPI agrees to pay LRH as follows:

a) BPI shall pay \$5,000.00 to LRH on execution of this agreement in consideration of this grant of rights from LRH. This payment is not an advance on royalties and is not repayable by LRH.

b) In addition, BPI shall pay LRH the following royalties based on sales of the calendars:

- (i) 4% on the first 10,000 calendars sold.
- (ii) 6% on the next 20,000 calendars sold.
- (iii) 8% on all calendars sold in excess of 30,000.

4. BPI shall prepare statements accounting for all payments due LRH under this agreement for each quarter ending 31 March, 30 June, 30 September and 31 December. Payments due LRH from BPI shall be paid weekly and shall be accompanied by an informal statement indicating the basis for payment.

5. The format, style and composition of the text, graphic material and captions of each edition of the calendar shall be determined by BPI with LRH's authorized representative, Author Services Inc, written consent.

6. The sales territory shall be the United States and Canada.

7. On publication of the calendar, BPI will give to LRH 50 free calendars and LRH may purchase additional calendars at BPI's maximum standard distributor discount available at time of the transaction. BPI further acknowledges LRH's reservation unto himself of the right to sell Artist autographed calendars and in connection therewith BPI agrees to supply, at cost of production to LRH, up to 100 calendars.

RE: FIRST EDITION COLLECTION PACKAGE

Dear Mr Hubbard,

The following will constitute the agreement between Bridge Publications, Inc. ("BPI") and L. Ron Hubbard ("LRH") with respect to the rights to produce and market a First Edition Collection Package containing the music of the book "Battlefield Earth" denoted "Space Jazz" in up to 5,000 (five thousand) copies.

1. LRH will supply 5,000 original Space Jazz long play records and 5,000 cassettes for inclusion in this package.

2. Bridge will undertake the manufacture, distribution and sale of the packages. Bridge shall use its best efforts to promote and procure maximum sales of the packages.

3. The territory for the purposes of this agreement is the United States and Canada.

4. In consideration of LRH's consent to the aforementioned, BPI agrees to pay LRH as follows:

a) Bridge shall pay LRH the following:

(i) \$33.75 per package sold at a retail price of \$225.00


(ii) \$33.75 plus a pro-rata portion of any increase in the retail selling price above \$225.00.

5. Bridge shall prepare statements accounting for all payments due LRH under this agreement for each quarter ending 31 March, 30 June, 30 September and 31 December. Payments due LRH from Bridge shall be paid weekly and shall be accompanied by an informal statement indicating the basis for payment.


