
ECCLESIASTICAL SUPPORT ORGANIZATIONS



SUMMARY DESCRIPTION OF ECCLESIASTICAL SUPPORT ORGANIZATIONS

IGN (the Inspector General Network) -- is a non-profit secular corporation which is the registered owner of the religious marks as nominee for RTC in countries where contracts by religious corporations are not enforced. This organization itself has no staff and its annual budget is approximately \$1,100, based on its annual disbursements for the most recent year for which financial statements are available.

WISE, Inc. — is a Delaware corporation that has served the same role as IGN prior to IGN's incorporation, i.e. as RTC's nominee for registration of the Scientology religious marks in certain foreign countries which do not recognize religious corporations or enforce their contracts. WISE, Inc. is in the process of transferring the marks it holds to IGN. When all transfers are completed, WISE, Inc. will dissolve. This organization itself has no staff and its annual budget is approximately \$350, based on its annual disbursements for the most recent year for which financial statements are available.

RTC Australia -- was incorporated in 1986 to serve as an Australian continental office for RTC. RTC subsequently decided not to establish continental offices. RTC Australia remains in existence although it is wholly dormant. It has no staff, minimal assets, has never received any income and has never paid a dividend. It is recognized in Australia as tax exempt.

FSO OIC (FSO Oklahoma Investments Corporation) -- is a taxable subsidiary of CSFSO formed to hold investments in oil and gas properties and real estate. This organization itself has no staff and its annual budget is approximately \$200,000, based on its annual disbursements for the most recent year for which financial statements are available.

FST (Flag Ship Trust) -- is a non-U.S. charitable trust that serves as a holding company for the various organizations which support CSFSSO's religious program aboard the ship, the SMV Freewinds, as follows:

San Donato Properties ("SDP") -- is a Panamanian corporation that is the registered owner of the <u>Freewinds</u>. This organization itself has no staff and its annual budget is approximately \$1.2 million, based on its annual disbursements for the most recent year for which financial statements are available.

Transcorp Services -- is a Panamanian corporation, which owns all of the shares of SDP and holds a mortgage on the <u>Freewinds</u>. All of Transcorp's shares are owned by FST. This organization itself has no staff and its annual budget is approximately \$1.2 million, based on its annual disbursements for the most recent year for which financial statements are available.

Majestic Cruise Lines ("Majestic") -- is a Panamanian corporation which actually operates the <u>Freewinds</u>, thereby allowing CSFSSO to limit its activities solely to the ministry of religious services. This organization itself has a staff of approximately 129 individuals and an annual budget of approximately \$10.6 million, based on its annual disbursements for the most recent year for which financial statements are available.

MCL Services, N.V. -- is a Netherlands Antilles corporation which provides shore support and liaison services for Majestic and CSFSSO from the <u>Freewinds</u>' home port. All of its shares are held by FST. This organization has a staff of approximately 5 individuals and an annual budget of approximately \$160,000, based on its annual disbursements for the most recent year for which financial statements are available.

FSS Organization, N.V. -- is a Netherlands Antilles corporation formed to facilitate CSFSSO's payment of taxes pursuant to its agreement with Netherlands Antilles tax authorities. All of its shares are held by FST. This organization itself has no staff or budget.

FST itself has no staff, and its annual budget is approximately \$6.8 million, based on its annual disbursements for the most recent year for which financial statements are available.

BMS (Building Management Services) -- owns and operates church real properties located in Southern California which it leases to various California-based churches. This organization itself has no staff and its annual budget is approximately \$3.5 million, based on its annual disbursements for the most recent year for which financial statements are available.

TFS (Trust for Scientologists) -- is a non-U.S. trust that holds unused advance contributions for religious services by CSFSO's non-U.S. parishioners, subject to the parishioners' instructions. TFS itself has no staff, and its annual budget is approximately \$750,000, based on its annual disbursements for the most recent year for which financial statements are available.

USPT (United States Parishioners Trust) -- is a U.S. trust that holds unused advance contributions for religious services by CSWUS's parishioners and by U.S. parishioners of CSFSO, subject to the parishioners' instructions. USPT itself has no staff, and its annual budget is approximately \$3.6 million, based on its annual disbursements for the most recent year for which financial statements are available.

CSRT (Church of Scientology Religious Trust) -- is a domestic trust which is the principal Scientology entity for reserve needs of United States churches. CSRT is recognized by the Service as exempt under section 501(c)(3). This organization has a staff of approximately 13 individuals and an annual budget of approximately \$18 million, based on its annual disbursements for the most recent year for which financial statements are available.

SIRT (Scientology International Reserves Trust) -- is a foreign trust which is the principal Scientology entity for reserve needs of foreign Scientology entities. SIRT itself has no staff, and its annual budget is approximately \$4.5 million, based on its annual disbursements for the most recent year for which financial statements are available.

SOR Services Ltd -- is a foreign corporation wholly owned by SIRT which performs administrative, bookkeeping and banking services for SIRT, TFS and FST. This organization has a staff of approximately 5 individuals and an annual budget of approximately \$300,000, based on its annual disbursements for the most recent year for which financial statements are available.

The Freewinds Relay Office (Church of Scientology Freewinds Relay Office, Inc.) -- serves as a liaison between CSFSSO and its support organizations and various organizations and individuals in the United States. This organization has a staff of approximately 9 individuals and an annual budget of approximately \$3.9 million, based on its annual disbursements for the most recent year for which financial statements are available.

HDF (Hubbard Dianetics Foundation) -- is a nonprofit religious corporation which assists dissemination of Scientology to the public through promotion of <u>Dianetics</u>. This organization itself has no staff or budget; its annual expenses are paid directly by CSI.

CADA (California Association of Dianetic Auditors) -- is a nonprofit corporation created by CSI in 1987 to reserve that corporate name in order to protect the integrity of the religious mark "Dianetics." It was and has remained a wholly dormant corporation with no staff, assets or budget.

WISE (World Institute of Scientology Enterprises) -- is a California nonprofit religious corporation that serves as a fellowship association for Scientology businessmen and women

which helps assure that churches remain distraction-free, instills religious ethical principles in business, and licenses marks associated with the religion and Mr. Hubbard to appropriate businesses. This organization has a staff of approximately 24 individuals and an annual budget of approximately \$4.3 million, based on its annual disbursements for the most recent year for which financial statements are available.

Mastertech -- is a California for-profit corporation which is wholly-owned by WISE. It is licensed by CSI (through WISE) to produce and sell the "How to Operate a Computer Course" which is an application of Mr. Hubbard's study technology to using a computer. Mastertech files Form 1120 Federal income tax returns and has never paid a dividend. This organization has a staff of approximately 3 individuals and an annual budget of approximately \$100,000, based on its annual disbursements for the most recent year for which financial statements are available.
