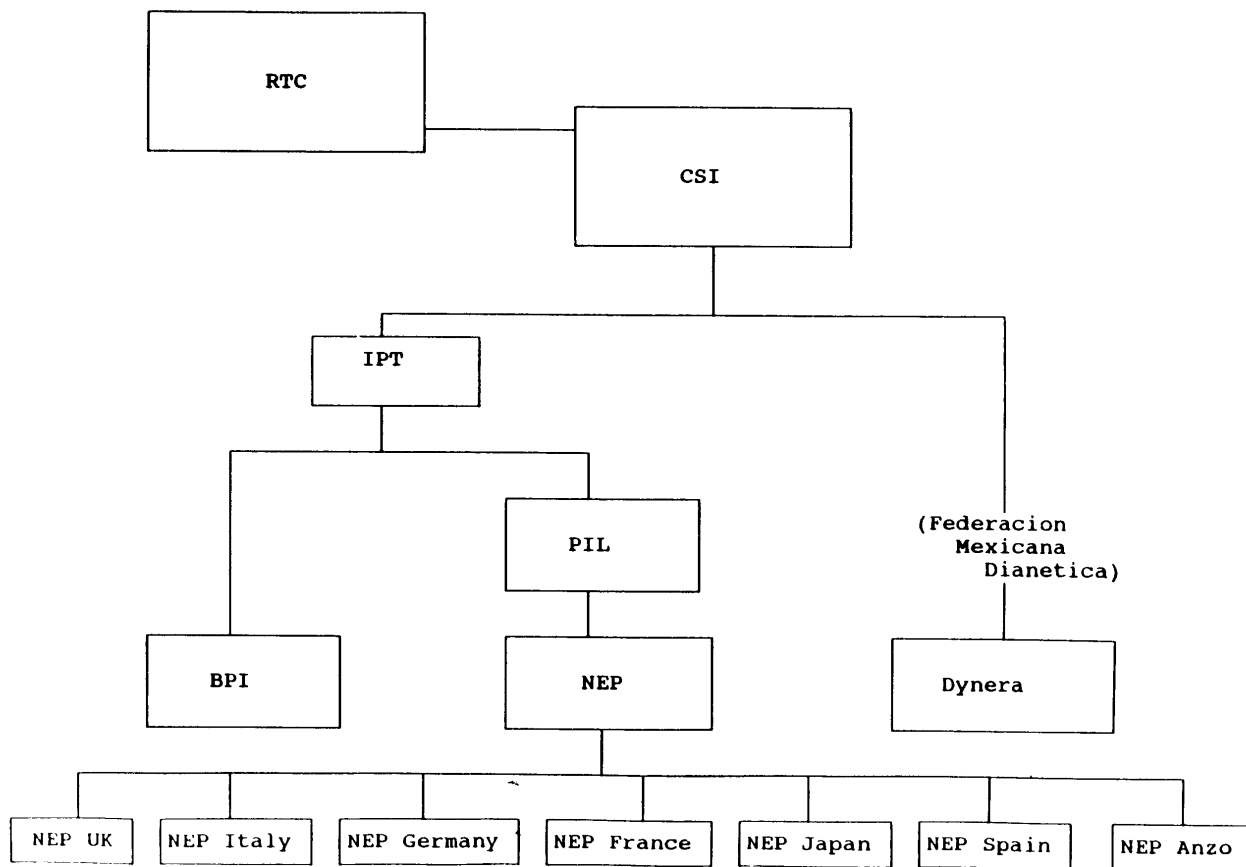

SUMMARY DESCRIPTION OF PUBLICATIONS ORGANIZATIONS

CSI -- produces tape recordings of Mr. Hubbard's recorded lectures and religious films from scripts written by Mr. Hubbard, which are part of the Scientology Scriptures. It also produces a number of films and videos used in the dissemination of Scientology to the public at large. Since April of 1988 CSI also has produced and repaired E-Meters.

IPT (International Publications Trust) -- is a non-U.S. religious trust which holds the stock of the companies that publish the Scientology Scriptures for the benefit of the entire religion. Any individual who serves as a trustee of IPT must be in good standing with CSI. IPT itself has no staff, and its annual budget is approximately \$15,000, based on its annual disbursements for the most recent year for which financial statements are available.

PIL (Publications Int Limited) -- is a U.K. corporation owned by IPT which holds the shares of NEP. IPT had to form PIL as an intervening corporate subsidiary to own NEP (see below) because of concerns as to whether Danish law would permit a trust to register as shareholder of a Danish corporation. PIL will shortly transfer its NEP shares to IPT and then dissolve. PIL itself has no staff or budget.

NEP (New Era Publications International, ApS) -- is a Danish Corporation that publishes and distributes the Scientology Scriptures and Mr. Hubbard's fictional works outside of North America. All of its shares are held by IPT indirectly, through PIL. NEP carries out its activities through the following wholly-owned subsidiaries in certain non-U.S. countries in which it has substantial printing and distribution operations or in countries where it is more feasible to operate through a local corporation:

New Era Publications UK, Ltd. This organization has a staff of approximately 8 individuals.

New Era Publications Italia, S.r.l. This organization has a staff of approximately 10 individuals.

New Era Publications Deutschland, Gmbh. This organization has a staff of approximately 3 individuals.

New Era Publications France, SARL. This organization has a staff of approximately 8 individuals.

New Era Publications Japan, Inc. This organization has a staff of approximately 4 individuals.

New Era Publications S.A. (Spain). This organization has a staff of approximately 2 individuals.

N.E. Publications Australia Pty. Ltd. This organization has a staff of approximately 10 individuals.

New Era Publications Israel. This organization has no staff and essentially is dormant.

NEP itself has a staff of approximately 88 individuals and an annual budget, including its subsidiaries, of approximately \$35 million, based on its consolidated annual disbursements for the most recent year for which financial statements are available.

BPI (Bridge Publications Inc.) -- is a California corporation which is responsible for publication and distribution in the United States and Canada of Scientology religious books and other Scriptural material and of Mr. Hubbard's fictional works. All of its shares are owned directly by IPT. This organization has a staff of approximately 85 individuals and an annual budget of approximately \$24 million, based on its annual disbursements for the most recent year for which financial statements are available.

Dynera (ERA Dinamica Editores) -- is a Mexican corporation that publishes and distributes the Scientology Scriptures in Mexico and Central America. Its shares are held by the Federacion Mexicana Dianetica ("Federation"), a Mexican corporation whose members are local Scientologists, and by staff of the Federation as its nominee. This organization has a staff of approximately 30 individuals and an annual budget of approximately \$300,000, based on its annual disbursements for the most recent year for which financial statements are available.
