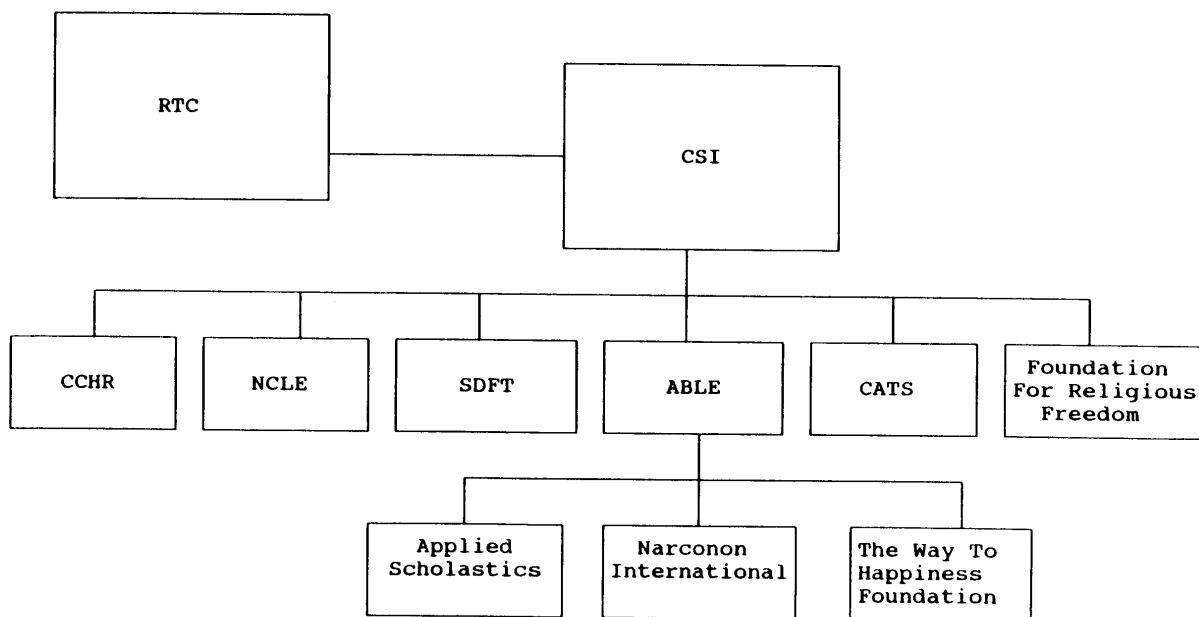

## SUMMARY DESCRIPTION OF SOCIAL BETTERMENT AND OTHER PUBLIC BENEFIT ORGANIZATIONS

ABLE (Association For Better Living and Education) -- is a non-profit corporation which promotes, funds, and provides assistance to organizations working to better society in the fields of education, drug rehabilitation, criminal rehabilitation, and public morality in general. This organization has a staff of approximately 26 individuals and an annual budget of approximately \$1.3 million, based on its annual disbursements for the most recent year for which financial statements are available.

Applied Scholastics, Inc. -- is a California nonprofit corporation working to better society in the field of education by providing guidance and technical support to schools throughout the world. Applied Scholastics, Inc. is recognized by the Service as exempt under section 501(c)(3). This organization has a staff of approximately 18 individuals and an annual budget of approximately \$1 million, based on its annual disbursements for the most recent year for which financial statements are available.

Narconon International -- is a nonprofit corporation working to better society in the field of drug rehabilitation by providing guidance and technical support to local drug rehabilitation organizations throughout the world. Narconon International also provides similar guidance and support to organizations involved in the rehabilitation of criminals. Narconon International has a group exemption ruling under section 501(c)(3) which covers its rehabilitation centers in the United States. This organization has a staff of approximately 69 individuals and an annual budget of approximately \$1.8 million, based on its annual disbursements for the most recent year for which financial statements are available.

The Way to Happiness Foundation ("the Foundation") -- is a California nonprofit corporation formed to raise the moral standards of society. Its principal activity is the public dissemination of a basic, non-religious moral code of principles and values for living an ethical and happy life called The Way to Happiness. The Foundation has an application for recognition of exemption under section 501(c)(3) pending. It has a staff of approximately 6 individuals and an annual budget of approximately \$300,000, based on its annual disbursements for the most recent year for which financial statements are available.

There also are a number of other Scientology-related organizations that operate for the public's benefit, separate from the ABLE group, as follows:

Hubbard College of Administration -- is a California nonprofit corporation recently formed for the purpose of offering the general public an educational program in organizational administrative management. The College's curriculum is founded on the writings of L. Ron Hubbard. It will be filing an application for recognition of its exemption under section 501(c)(3) soon. Because it is a new organization in its formative stages, it has no staff yet and no past operations from which a budget figure can be determined; thus, the College is not included on the organizational chart or the flow of funds chart (Exhibit 9).

CCHR (Citizens' Commission on Human Rights) -- is a nonprofit corporation dedicated to investigating, publicizing and stopping human rights violations committed through the guise of psychiatric "treatments" and to recommending humane alternatives to such practices. CCHR is recognized by the Service as exempt under section 501(c)(3). There are local CCHR chapters throughout the country, and CCHR has an application for a group exemption pending before the National Office. This organization has a staff of approximately 23 individuals and an annual budget of approximately \$600,000, based on its annual disbursements for the most recent year for which financial statements are available.

NCLE (National Commission on Law Enforcement and Social Justice) -- is a recently-formed nonprofit corporation whose mission is to guard against abuses resulting from corruption in law enforcement and other governmental agencies that violate the United States Constitution or the Universal Declaration of Human Rights. NCLE is recognized by the Service as exempt under section 501(c)(3). There are local NCLE chapters throughout the country. This organization has a staff of approximately 7 volunteers and an annual budget of approximately \$1,400, based on its annual disbursements for the most recent year for which financial statements are available.

SDFT (Scientology Defense Fund Trust) -- is a nonprofit religious trust formed for the purpose of defending individuals whose human and civil rights are threatened because they are Scientologists. It is recognized by the Service as exempt under section 501(c)(3). This organization itself has no staff and its annual budget is approximately \$100, based on its annual disbursements for the most recent year for which financial statements are available.

CATS (Citizens for an Alternative Tax System) -- is a social welfare organization involved in educating the public about alternatives to the present federal income tax system. CATS' application for recognition of its exempt status under section

501(c)(4) is pending before the National Office. This organization has a staff of approximately 3 individuals and an annual budget of approximately \$25,000, based on its annual disbursements for the most recent year for which financial statements are available.

The Foundation for Religious Freedom -- is a nonprofit trust that safeguards religious freedom throughout the world by monitoring, exposing and seeking to remedy governmental and private conduct which threatens freedom of religious worship. It is recognized by the Service as exempt under section 501(c)(3). This organization itself has no staff and its annual budget is approximately \$2,500, based on its annual disbursements for the most recent year for which financial statements are available.
