As the result of an idea originated by Scientology® Churches in Europe an International Convention was held at Saint Hill in England on 7 and 8 October 1984. The subject being taken up was the expansion of Scientology and the fact that suppression of and attacks on Scientology increase when we expand as suppressives get desperate when Scientology expands, this expansion meaning freedom for the individual. The suppression of individuals, groups and religions has over the years impeded survival and been threatening the future of this planet and the universe.

Delegates from Churches all over the world attended this convention. At the convention a Pledge to Mankind was made and signed by all delegates. This pledge ends with these words: "We, the undersigned, pledge ourselves, without reservation or any thought of personal comfort or safety, to achieving the aims of Scientology: 'A civilization without insanity, without war, where the able can prosper and honest beings can have rights, and where Man is free to rise to greater heights.' We invite Scientologists and other well-intentioned people everywhere to join us in this pledge. Witness our hand this Seventh day of October, A.D. 34. Saint Hill Manor, East Grinstead, Sussex, England."

It was then decided to form an International Association of Scientologists with the purpose to UNITE, ADVANCE, SUPPORT AND PROTECT SCIENTOLOGY AND SCIENTOLOGISTS IN ALL PARTS OF THE WORLD SO AS TO ACHIEVE THE AIMS AND PURPOSES OF SCIENTOLOGY.

The convention and the forming of the Association was blessed by the Church of Scientology International and the Association began its work.

This event truly was a history making occurrence in Scientology.

THE FIRST STEPS

One of the first actions of the Association was the writing of an open letter to all Scientologists in which the Association presents itself to all Scientologists and lays out the purpose and functions of the Association. In this letter the intention of the Association is stated to be to gather and unite all Scientologists on this planet and create a worldwide strong true group through the contribution and participation of Scientologists. It was decided to get a membership system worked out, and the Church was requested to propose dues as well as other details concerning the membership system so as to coordinate the activities of the Church with the activities of the International Association of Scientologists. It was proposed to have an Annual Membership at a minimum fee of \$300 (or equivalent in foreign currencies) and a Lifetime Membership with a minimum fee of \$2000 (or equivalent in foreign currencies). This was agreed upon by the Association.

The first step to make this Association known was a series of events which were held on 19, 20 and 21 October 1984 in many major Scientology areas around the world so that as many Scientologists as possible could be informed about the existence of the Association. A total of 16 events were held in Clearwater (Flag), Los Angeles, New York, Boston, Washington DC, Toronto, Mexico, East Grinstead (Saint Hill, England), Copenhagen, Stockholm, Paris, Milano, Munich, Zurich, Johannesburg and Sydney.

These events were attended by more than 20,000 Scientologists who in many cases came from far away to hear the news and find out what had been occurring. The response from Scientologists was an overwhelming enthusiasm which resulted in thousands of Scientologists applying for their memberships and volunteering to help out in their local Churches to support the purpose of the Association. Many Scientologists applied for their Annual and Lifetime Memberships and additionally donated large amounts to the Association. Large donations were further pledged all over the world.

HOW TO BECOME A MEMBER

To become a member one needs to fill out an application form which gives a choice between Annual Membership and Lifetime Membership. The application form and payment of the fee and additional donations are then simply forwarded to the Association either directly or by handing it to a Church staff member who will then forward them to the Association. Upon receipt of the application form and payment, the Association will forward a membership card and a "Welcome to the Association" pack. This pack will contain the data on the rules and benefits for members of the Association.

INTERNATIONAL ASSOCIATION OF SCIENTOLOGISTS
AND THE CHURCH

It must be understood that the International Association of Scientologists (IAS) is a different entity than the Church. It is not part of the Church, and the Church is not part of the Association. The Church has no authority over the Association and no command lines into it. Similarly the Association has no authority over the Church or any command lines into the Church.

That means that the payment of membership fees and donations do NOT go to the Church. Such payments are NOT to be invoiced by any Church staff member for any reason. The payments are for the Association and are to be forwarded to it where the payments will be invoiced.

Thus the role of the Church in this is to inform Scientologists of the existence and purpose of the International Association of Scientologists and provide the needed information and help to all Scientologists to become members. Since the Association has as its purpose to unite, advance, support and protect Scientology, the Church has a strong interest in backing up and helping to make it a strong group with all Scientologists as members. It is recognized by the Church that the International Association of Scientologists is the guarantee that Scientology will always be there and as such the Church is fully and completely behind the Association and taking measures to ensure that the Association becomes large and strong through its membership.

MEMBERSHIP OFFICER

The Church staff member responsible (as assigned by the Church) for Scientologists being informed of the existence of the International Association of Scientologists and that application forms are available and that the lines are in at Church level so that Scientologists can easily and smoothly become members, is the Membership Officer (or Membership I/C) which is a post in Division 6C. This person also administers other types of memberships, such as memberships of I WANT TO GO OT CLUB and local Church membership. If this post is not manned by a single person it is held from above by Field Control Sec or Public Exec Sec or is double hatted as designated by the Public Exec Sec.

The Membership Officer is working for the Church and is not a representative of or a staff member in the International Association of Scientologists. No one in the Church can say he is representing the Association, but Church and Mission staff members can and should help the Association and support it in any way possible. No part of any payments for dues to the Association may be invoiced or spent by the Church.

A unit has been formed in Los Angeles which oversees and supervises the activities of the local Membership Officers on an international basis. There is an International Membership I/C on post and specialist staff posted in the unit to ensure that the functions of the unit are carried out and Scientologists be made members of IAS. This unit is there to ensure that Membership Officers are posted and functioning and that the needed promotion and forms are made available. Its purpose is to make the IAS a large and strong association by getting volume Scientologists to join up and building a network which will ensure that memberships continue to grow.

THE FUTURE

It is expected and hoped that every Scientologist around the world joins up and becomes a member of the International Association of Scientologists. It is after all the Association which will make very sure that Scientology will always be there, so that you and your friends and family and your fellow man can get the Technology which will give them and this universe the gift of total freedom. Do not underestimate the importance of this.

Churches - a convention was held at Saint Hill in England to
discuss the subject of Scientology expansion and the future of
religious freedom. At this convention, attended by representatives
from Scientology Churches around the world, a Pledge to Mankind
was made and signed by all delegates. This was followed by the
creation of the INTERNATIONAL ASSOCIATION OF SCIENTOLOGISTS™. The
stated purpose of this new association is:

"TO UNITE, ADVANCE, SUPPORT AND PROTECT SCIENTOLOGY AND
SCIENTOLOGISTS IN ALL PARTS OF THE WORLD SO AS TO ACHIEVE
THE AIMS AND PURPOSES OF SCIENTOLOGY."

In light of this purpose, aligned as it is with the aims of
the Church itself, the Church of Scientology International intends
to support the Association fully in its crusade for the creation
of a powerful Third Dynamic of Scientologists united in the fight
for freedom. As one expression of its support of this new
organization, the Church has elected to adopt membership in the
International Association of Scientologists as an official
membership for its parishioners, replacing the "International

Membership" which has been in use in recent years. Illegally issued in the Founder's name, that membership system was actually an alter-is of the Founder's original policies and advices regarding memberships. It is on these Source materials that the Church has based these corrected policies with regard to this new membership program.

[Note: It must be understood that the International Association of Scientologists (IAS) is in fact separate from the Church. The Association's rules are laid out and issued by the Association itself, and the Church assists in forwarding membership applications and fees submitted by Church parishioners. There are some Churches which will continue to require membership in the local Church, according to their own rules and local laws of incorporation. Such memberships are not cancelled or changed by this issue.]

4. Eligibility for appointment as a Field Staff Member. (Ref: HCO PL 9 May AD15RA, Revised and Reissued 8 Nov 1984, FSM Series 1, FIELD AUDITORS BECOME STAFF)
5. Special rates on membership fees for the "I Want To Go OT" Club. [Note that this International Association of Scientologists membership program does not cancel or replace the "I Want To Go OT" Club or its membership program and benefits.]
6. Special rates on Dianetics™ and Scientology materials and services not otherwise covered, as announced by the Church from time to time.

These benefits are available to members of the International Association of Scientologists ONLY. They are additional to those extended by the Association itself, as announced by IAS.

PHASING OVER TO INTERNATIONAL ASSOCIATION OF SCIENTOLOGISTS MEMBERSHIP

Phase-over to this new membership program is done first by ensuring that all staff and public are well briefed on the

Association and on this issue so that they fully understand the purpose of the IAS, why it has been formed and why the Church has adopted membership in the Association as its official membership program.

The Association is there to ensure that Scientology and The Bridge will always be available and it is in the interest of every individual Scientologist to forward this intention while he continues full speed on his own way up the road to total freedom. It is HIS Association. It is there to safeguard The Bridge.

Briefing packs on the Association, its origin, goals, purposes, activities, and a description of some of the benefits that go with membership are available from the International Membership I/C. They may be used to familiarize Scientologists in your area with the Association and what they must do to become a part of it.

MEMBERSHIP SIGN-UP LINE

Registrars must be well briefed and generously supplied with application forms so that sign-ups for IAS Membership can be done smoothly and without delays. Reges must also be supplied with materials on the International Association for use in educating their reg prospects. Signing a parishioner up for Association membership is a simple matter: The person fills out the application form and makes payment for either Annual Membership (\$300 US or as issued in other currencies) or Lifetime Membership (\$2000 US or as issued in other currencies), payable to the International Association of Scientologists, c/o Saint Hill. The application and payment are then relayed to the Association.

Donations for membership fees are NEVER invoiced by Church staff, nor may they be debited from funds the person has on account with an org or mission, as these are payments to the Association and not the Church. These donations are non-refundable and are not tax-deductible for the donor. Payments to the Association may be handed, with application form attached, to the FBO who will forward them to the Continental Finance Director. From there the payments and applications are relayed to the Association. FREE BEGINNING MEMBERSHIP

In addition to the Annual and Lifetime Memberships, there is a free Beginning Membership. This is a Membership for new public who are just beginning their first service with the Church, buying their first book, etc. New public are normally signed up for this membership by Div 6 Registrars. It is valid for 6 months and entitles the member to the benefits listed above (section headed "Membership Benefits") and as may be additionally issued by the Association specifically for Beginning Members.

Any public person currently holding 6 month free membership under the previous membership system is simply transferred to Beginning Membership in the Association. This means that if the person's free membership has been in force for 4 months, he is transferred immediately to Beginning Membership in the IAS, which will remain valid for 2 months.

When a Beginning Membership expires, the member is re-signed for an Annual or Lifetime Membership in the International Association of Scientologists.

No Scientologist who has been receiving paid major services from the Church will be granted a Beginning Membership by the Church regardless of whether or not he he was granted one on starting his first Scientology or Dianetics services. Such persons would be signed up for Annual or Lifetime Membership immediately as it gives them full rights and privileges.

PUBLIC CURRENTLY RECEIVING SERVICES

Public already in progress on Church services should be Annual or Lifetime Members (or in the case of new public, 6 month free members). Privileges for HASI Lifetime Members still apply per SPD 120 HASI MEMBERSHIP CLARIFICATION OF STATUS AND BENEFITS. All registration cycles should include briefing of the parishioner on the new membership system and signing him up for membership.

RESPONSIBILITY

The Membership Officer in Department 18B, Division 6C, is responsible for seeing that ALL Scientologists in his area are informed about the IAS and about this new membership system, its purposes and benefits, and for helping them to join the Association. He does this with these steps:

1. Make sure you have a generous supply of briefing packs and application forms for the International Association of Scientologists, and get them straight into the hands of all public in your org or mission. Get every one of them signed up and forward their application forms and donations to the Association.

2. Make full use of all promotional materials (briefing packs, brochures, fliers, posters, videos, etc.) to inform and interest new public coming into the org, and get them signed up.
3. Set up a table and display (complete with promotional materials, plenty of application forms, pens, envelopes, and a box for completed applications and donations) in a public area in the org where public can find out about the Association and sign up. Check the box regularly and get the applications forwarded.
4. Do a call-in of public not currently on lines. Let them know that a new association has been formed to unite Scientologists in the fight for freedom. Get them to come in and find out more about it. As they come in, get them fully briefed on the International Association of Scientologists and this membership program - then get them signed up as Annual or Lifetime Members.
5. Contact Membership I/C at Flag and let him know of your progress, stats and wins with these steps and this new membership program. He can help you out with any bugs, see that you get more materials or application forms as needed, etc.

2. Make full use of all promotional materials (briefing packs, brochures, fliers, posters, videos, etc.) to inform and interest new public coming into the org, and get them signed up.
3. Set up a table and display (complete with promotional materials, plenty of application forms, pens, envelopes, and a box for completed applications and donations) in a public area in the org where public can find out about the Association and sign up. Check the box regularly and get the applications forwarded.
4. Do a call-in of public not currently on lines. Let them know that a new association has been formed to unite Scientologists in the fight for freedom. Get them to come in and find out more about it. As they come in, get them fully briefed on the International Association of Scientologists and this membership program - then get them signed up as Annual or Lifetime Members.
5. Contact Membership I/C at Flag and let him know of your progress, stats and wins with these steps and this new membership program. He can help you out with any bugs, see that you get more materials of application forms as needed, etc.
