Gentlemen:

In addition to welcoming the establishment of International Association of Scientologists, we must ask you to modify your practices in connection with our trademarks and services marks, to avoid possible problems in the future.

First and most important, we have not consented to your use of the Scientology symbol that appeared on the cover of the folder distributed at the recent convention. You must discontinue all use of that symbol, and refrain from future use of all our marks on your materials.

Second, we note that you are using "R" and "TN" symbols with "Scientology" and "Scientologist" that may be misleading with respect to ownership of these Marks, In the future, please replace the "R" and "TN" symbols with an asterisk (as Scientology", Scientologist*) and put a footnote notice on any documents where these terms appear, as follows:

Ex. II-9-E

"Dissettie TM spiritual heefing technology, Jeientology & applied religious philosophy" The Religious Technology Chules, 4781 Fountain Avenue, Lee Angeles, California 10020

. "Scientology" is a registered trademark and service mark owned by Religious Technology center, and "scientologist" is a collective membership mark designating members of the affiliated Churches and Missions of Scientology.

This notice will insure that your uses of these marks do not give the impression that you are a licensee.

Please indicate your agreement by signing, dating and returning the enclosed extra copy of this letter.

Dear Gentlemen:

As you no doubt realize, an organization named "International Association of Scientologists" was created at St. Hill Menor on 7 October 1984, for the purpose of collective activity for the benefit of the organized religion throughout the planet. The purpose of this letter is to give you official notice of our intentions and to determine whether you have any objection to what we are planning.

At this stage, we anticipate that this association will have meetings from time to time for discussion and fellowship, will publish a newsletter for its members dealing with activities and events of interest to Scientologists and will engage in other activities of this type that are usual to such as association. Annual dues will be established, and a membership card or certificate will be issued.

We will be seeking the cooperation of the effiliated Churches and Missions of Scientology in informing all Scientologists about the availability and benefits of sembership in the association. Of course, we will limit

RH19 4BR membership to those individuals who are in good standing with an official Church or Hission, so as to be entitled to be called a Scientologist. If organizations are allowed to become members, only affiliated and licensed organizations will be accepted.

We believe that the descriptive phrase "International Association of Scientologists" is the appropriate name for the association, and we plan to use this title unless you have an objection. We will not use any of your trademarks or service marks, beyond "Scientologist", except in factual and accurate reference to the affiliated organizations, members and their services, products and activities. We understand that this kind of use does not require a license and is not an infringement. Of course, if you have any objection to any of our activities, we will do whatever you may require to correct that objection.

Please let us know as soon as possible if you are in agreement with the above.
