Re: Foundation of an international association for Scientologists

Church of Scientology AOSH EU & AF has had discussions with other Scientology Churches in Europe and America concerning the wish to form a joint association for all Scientologists and all Scientology Churches in the world, and we hereby invite you to a founding meeting.

17. We have submitted our proposal to Church of Scientology International and we have received acceptance of our proposal - see enclosed copy.

17. The idea is to form an association based on the fundamental rules contained in the enclosed draft Constitution. These fundamental rules will be the frame for designating the finite association rules. These rules will be worked out by the Board of Directors which expectedly will be elected at the founding meeting.

In case you have an interest in the proposal, we request you to appoint one or more delegates (whom, however, will have only one vote) to attend the founding meeting, which for historical reasons will be held at Saint Hill Manor, East Grinstead on

Sunday and Monday, 7 and 8 October 1984

The meeting is expected to last for two days.

In case you wish to be represented, we ask you, in view of i.a. hotel reservations, etc., to inform us that you will be attending, who will represent you and arrival time.

As it is vital in regards to the founding, that the Constitution fulfills all the requirements of the founders, and as it is important that the Board of Directors of the Association receives all wishes for use in drafting the association rules, we ask you to carefully review the draft Constitution ahead of the meeting - this to ensure that all proposals be submitted in the meeting

17. We enclose an agenda for the meeting.

This invitation has been sent to 20 Churches of Scientology selected by us, which should cover all areas in the world.

INTERNATIONAL ASSOCIATION OF SCIENTOLOGISTS  
CONSTITUTION

There is hereby created an Association which shall have perpetual existence under this Constitution until dissolved in accordance with the provisions thereof.

ARTICLE I - NAME

The name of this Association is INTERNATIONAL ASSOCIATION OF SCIENTOLOGISTS.

ARTICLE II - GOALS AND PURPOSES

The Goals and Purposes of this association are the Goals and Purposes of the Religion of Scientology as founded and developed by L. Ron Hubbard.

The specific Purposes of this Association are to advance, protect and defend the Religion of Scientology and to assist, protect and defend its Members throughout this Planet.

ARTICLE III - GOVERNANCE

This Association shall be governed by a Board of Directors.

The Board of Directors shall adopt Rules (which shall be consistent with this constitution) for the governance of the Association, the conduct of its activities and the qualifications, rights, privileges and duties of its Members.

ARTICLE IV - MEMBERS

The Members of this Association shall be the Individuals, Churches and Missions who meet and continue to meet the

requirements of this Constitution and of all Rules adopted by the Board of directors.

The Individual Members shall be those Scientologists who meet the standards, qualifications and requirements established by the Board of Directors of this Association.

The Church members shall be limited to Churches of Scientology of Class IV and above.

The Mission Members shall be limited to Church of Scientology Missions.

The Rules adopted by ~~the~~ Board of Directors shall establish procedures for the admission and expulsion of Members, may provide for categories of Members and may require the payment of dues by all Members or by the Members in any category.

The initial Members shall be the undersigned Delegates who by their act have this day created this Association.

#### ARTICLE V - BOARD OF DIRECTORS

The Board of Directors shall consist of not less than three nor more than eleven individuals each of whom shall be a Minister of Scientology duly ordained by and in good standing with a Church of Scientology of Class IV or above.

Each Director shall continue in office until he or she resigns, dies, becomes incapacitated to act as a Director, fails to meet the qualifications to be a Director, is removed from office by action of the Board of Directors or is succeeded in office by the election of a successor.

Any interim vacancy shall be filled by action of the Board of Directors.

The Board of Directors shall adopt a rule for the selection of Directors in the event that there shall be no remaining Director.

The Board of Directors shall act in all matters by the majority vote or unanimous written consent of the incumbent Directors (or by the written act of the sole remaining Director if there shall be but one incumbent Director).

No Director shall have any right or authority to represent, act for or bind this Association unless, then only to the extent, authorized by the Board of Directors by its special resolution.

#### ARTICLE VI - ELECTION OF DIRECTORS

The number of Directors on the initial Board of Directors shall be determined and the initial Directors shall be elected by the Delegates to the Convention which adopts this Constitution.

The number of Directors may be changed and successor Directors shall be elected by Delegates at subsequent Meetings.

The Delegates at a Meeting may elect successor Directors from among themselves.

#### ARTICLE VII - MEETINGS OF DELEGATES

The Delegates at this Convention are and the Delegates who elect successor Directors shall be Scientologists who are qualified to be Directors of this Association.

This Convention and each subsequent Meeting of Delegates shall establish the month and year of the next Meeting of Delegates, which shall convene on such day and at such place as shall be determined by the Board of Directors.

Interim Meetings of delegates may be called by the Board of Directors at any time.

The Board of Directors shall give the Church Members notice of the time and place of each Meeting of Delegates at least thirty days prior thereto, by such means as shall be determined by the Board of Directors. The Notice shall state the purpose for which the Meeting has been called, but other matters may be taken up with the approval of the Delegates at the Meeting.

The Delegates at each Meeting shall elect a Chairman and a Secretary, who shall certify all actions taken at the Meeting.

The conduct of the Meeting of Delegates shall be controlled by the Delegates consistently with this Constitution, provided that all decisions shall be by majority vote of the Delegates who are present in person or by proxy except as otherwise expressly stated in this Constitution.

#### ARTICLE VIII - SELECTION OF DELEGATES

One Delegate to each Meeting of Delegates shall be selected by each Church Member to represent the Individual members who are its parishioners and who are the parishioners of all of the Mission Members within its ecclesiastical jurisdiction.

More than one Church Member may select the same Delegate.

Each Delegate shall have one vote for each Church member which designated him or her, plus one vote for each Mission Member within the ecclesiastical jurisdiction of each Church Member which designated him or her.

Each Church member shall control the manner of selecting its Delegate in accordance with its own Constitution or other Governing Instrument.

Failure of any Church Members to select Delegates or of any selected Delegates to attend shall not invalidate or delay any Meetings of Delegates, provided, however, that no action may be taken by a Meeting of Delegates unless Delegates selected by not

not less than one third of the Church Members are present in person or by proxy.

#### ARTICLE IX - LIMITATIONS

This Association is organized and shall be operated exclusively to benefit its Members by the realization of its Goals and Purposes.

This Association shall not engage in any activity, expend any funds or dispose of any other assets for the private benefit of any Director or other individual or organization.

This Association shall not engage in or conduct any business activity other than the management and investment of its assets.

This Association, recognizing that its Members exist under the laws of many Nations and respecting the Laws of each Nation and the right of each to establish its own Government, shall not engage in politics and shall impose no condition nor require nor encourage any activity on the part of any Member which would result in a violation or evasion of such Laws or be directed to the overthrow of or interference with Constituted Authority.

This Association, recognizing that the oppression of Religion and of freedom have occurred from time to time throughout history, and in order to assure the unimpeded accomplishment by this Association of its Goals and Purposes, shall not take any action which would subject this Association to the Power of any Nation at a time that Nation tolerates, aids or engages in the oppression or harrassment of any Religion or of Mankind, but shall take such action as shall be consistent with this Constitution, lawful and appropriate to assure that all of the Members who are subject to such Power may continue to practice and disseminate the Religion of Scientology.

This Association shall not manage or govern the Church Members or the Mission Members but shall leave such management and

governance to their duly constituted governing bodies and officers.

No Delegate or Member shall manage or govern this Association, but all shall leave such management and governance to its Board of Directors.

No Delegate or Member shall have the right, authority or duty to represent, act for or bind this Association unless, and only to the extent, authorized by the Board of Directors of this Association by special resolution.

No Delegate, Member or Director shall have any right to or claim against any asset of this Association except as shall result from any special agreement or transaction entered into by this Association by authority of its Board of Directors.

No Delegate, Member or Director shall be laible for the debts or responsible for the activities of this Association.

#### ARTICLE X - MEANS

This Association shall accomplish its Goals and Purposes by such lawful means as shall be consistent with this Constitution, which may include the acquisition, holding and disposition of property, the making of contracts, the formation of incorporated or unincorporated associations under the Laws of any Nation or Nations and any other act, action or activity which shall seem to the Board of Directors to be necessary or desirable to accomplish those Goals and Purposes.

#### ARTICLE XI - AMENDMENT AND DISSOLUTION

This Constitution may be amended by the Delegates at any Meeting by the adoption of an amending resolution by the affirmative vote of three quarters of all of the votes cast, but the Goals

and Purposes as stated in Article II shall not be changed.

This Association may be dissolved by the Delegates at any Meeting by the adoption of a resolution calling for such dissolution by the affirmative vote of the three quarters of all of the votes cast.

Upon dissolution the net assets (if any) of this Association shall be distributed for exclusively charitable and religious purposes, as shall be determined by the Meeting of Delegates.

#### ARTICLE XII - CHOICE OF LAW

This Constitution and all Rules adopted by the Board of Directors, and the rights, duties and privileges of this Association and of its Members thereunder, shall be construed and determined in accordance with the Common Law.

#### ARTICLE XIII - ADOPTION

This Constitution is hereby adopted by the undersigned Delegates in Convention assembled at Saint Hill Manor, East Grinstead, England, this \_\_\_\_\_ day of \_\_\_\_\_, 1984.

# Pledge to Mankind

*'Time and again, throughout the troubled history of civilization on this planet, new ideas, new religions and constructive thought have met with violent opposition. Such attacks come from those who would preserve the status quo and particularly from those who seek to preserve and enhance their position through the domination, subjugation and even destruction of others. For this reason new religions have been born in blood at the cost of great sacrifice and suffering by adherents. It is only through a unity of purpose and unwavering commitment by a dedicated group that new ideas and new religions survive and expand.*

*Scientology has been in existence now for some thirty four years. During that time it has suffered all manner of attacks from the forces of oppression in various countries. Yet Scientology has survived and expanded because of the dedication of its members and because it is a force for goodness and freedom which is easily recognized by men of goodwill despite the vicious lies which are spewed by those who would enslave mankind and which are carried by the media.*

*Scientology is experiencing the greatest expansion and prosperity in its history International in scope, Scientology each week frees more people from the debilitating effects of drugs, ignorance and other sources of aberration and moves them on the path to greater awareness, self respect and dignity than all other groups combined.*

*'Yet as we have learned in our thirty four years, whenever we expand, we are attacked, commensurate with that expansion. And today is no exception.*

*In the United States, which was once thought to be a haven of religious liberty, we are the targets of unprincipled attacks in the court system by those who would line their pockets from our hard won coffers. Bigots in all branches of government, fearing the success of Scientology, are bent on our destruction through taxation and repressive legislation.*

*We have been subjected to illegal heresy trials in two countries before prejudiced and malinformed judges who are not qualified or inclined to perceive the truth.*

*In Canada and Germany, our Churches have been subjected to vicious raids reminiscent of the historical genocide attacks on religions that took place in 'less*

*informed' times and societies. The news media chooses to ignore the good works and miraculous successes of Scientology and instead seeks to poison public opinion through vilification of the religion and its Founder.*

*'The detractors of Scientology know full well that it is a proven, effective and workable system for freeing mankind from spiritual bondage. That is why they attack. They fear that they will somehow be threatened by a society which is more ethical, productive and humane through the influence of Scientology and Scientologists. Thus when we expand, to that degree we are attacked.*

*'Up to this day the responsibility for defending Scientology has been on the shoulders of a desperate few. And so it will continue in large measure.*

*'Yet, in order to continue the quest for a new civilization where honest men have rights and freedoms abound, the assistance and dedication of each and every Scientologist and other men of goodwill is essential. The road may be difficult and may get worse due to the rapid decline of civilization and erosion of personal liberties at this time. But united in purpose and dedication, we shall prevail for the benefit of all mankind.*

*'We, the undersigned, pledge ourselves without reservation or any thoughts of personal comfort or safety, to achieving the aims of Scientology. A civilization without insanity, without criminals and without war, where the able can prosper and where honest beings can have rights and where Man is free to rise to greater heights.'*

*'We invite Scientologists and other well intentioned people everywhere to join us in this pledge.*
