SNOW WHITE PROGRAM.

Policy:

Attack is necessary to an effective defense.

SITUATION:

Countries are being denied to OTC, the "Apollo"

and LRH.

STATISTICS:

A gradual reduction of available countries

occurring since 1967, trend DANCER.

DATA:

General operating record since 1967, studded with many untoward incidents without foundation in fact. Each of these has had in common false

reports.

Recent exposures of official records have brought about the possession of data showing that England and the US have in the past spread false reports in several other countries which have caused

trouble.

WHY:

By spreading false reports a cumulative file can be built in their own and other countries which then tend to act on the file without the presence of the real scene data which is factually good but which is then ignored.

SECONDARY WHY: The tendency or habit of police and immigration agencies to act secretly on secret data without further advice, thus making a hidden third party

situstion.

IDEAL SCENE:

All false and secret files of the mations of operating areas brought to view and legally expunged and OTC, "Apello" and LRH free to frequent all western ports and nations without threat and all required ports open and free.

HANDLING:

Plan:

To engage in various litigation in all countries affected so as to expose to view all such derogatory and false reports, to engage in further litigation in the countries originating such reports, to exhaust recourse in those countries and then finally to take the matter to the United Nations (that now being possible for an individual and a group) and to the European Commission on Human Rights, meanwhile uprooting and cancelling all such files and reports wherever found.

Cautions

The UN and the European Commission throw out the vast majority of petitions as inadmissable on exact and tiny legal and technical points so that to be successful the most careful handling must be done with regard to these points.

#### GENERAL STRATEGY:

We will bring legal pressure by litigation in every possible country (where there has been a false report or offence) against England and the US as well as in England and the US so that the sum tetal will be to place these countries in a villainous light, not to be trusted as to data, and to cancel out all tendencies to false report as well as amend eld ones. And then tackle them through the two International Commissions.

## PRIMARY:

- 1. An efficer on Flag is to be appeinted to a co-ordinating and data accumulation post on Flag with the title OTC LEGAL PROGRAMS CHIEF.
- 2. A limison personnel is to be appointed at GO WW with the title OTC LEGAL OFFICER, Europe.
- 3. A limison personnel is to be appointed at GO US with the title OTC LEGAL OFFICER US.

Note: Nos. 2 and 3 may be classed as "Additional Duties" but only so long as the hat actually exists and is worm. In No. 1 it is a sole duty and must concern itself only with the SNOW WHITE programme.

- L. Under the direction of the OTC ASST. all persons connected with the programme are to be provided with copies of all pertinent legal papers and documents as they apply to their areas, and fully briefed.
- 5. Originals in all cases are to be most scrupulously safeguarded and only copies used and circulated, said copies to be of the highest possible photestat quality.
- 6. All decisions that in any way appear to deviate from this programme are to be cleared with the Controller as well as all matter in doubt.
- 7. Funds to be provided where extra funds are needed from grants from the HFO or AS, with care that such grants do not violate the nature of the HF and AS and that nominal wages and small expenses are part of usual operating costs or deductible from charter fees.
- 8. That me compromise of the C, of S, and OTC separate character may be made, so that OTC is by reason of these actions, not seen to be exerating in these countries but only that it has obtained legal assistance, and it is engaged only upon a legal matter.

### VITAL TARGETS:

- 1. That these matters be pushed rapidly and continually and industriously.
- 2. That he delays or errors are the result of OTC ommissions or commissions as such delays and errors are the commonest reason for losses of legal actions.
- 3. The exact technical stipulations of the UN and Eu Commissions be given the strictest attention and met in all earlier proceedings as well as in the eventual submissions to these Commissions, the most important being that all recourse has been fully exhausted in the countries (UK and US) before a petition can be considered admissable as well as other prints opposed in the referenced literature.

- 4. A board is to be made up to act as a Progress Board at the location of OTC Legal Pgm Chief. It is to have the name "Snow White Board" across the top. Then across the board horizontally, each code name is to be printed vertically (on edge). To the left a vertical column is to be made; it is to have (a), (b), (c) etc. to indicate target In Prog. or Completed. In this way the various projects can be kept track of, acted on or mudged. The board is to be kept up to date.
- 5. A set of files in a locked file cabinet is to be made, one file for each project. It is to be kept filed into so that at any moment its file is complete. The whole file is to be removed when work is being done on the project to which it relates and then when the work is done, despatches mailed or duplicates made and sent or telexes answered, the file, with the new copies or notes of actions is restored to the file cabinet. In this way evaluations can be done and a viewpoint of the project is retained.
- 6. A similar board and file is to exist at GO WW and GO US, made up by the OTC appointees and kept up by them, except that only those targets that apply to their areas are kept track of by them.
- 7. At all times the decision of the Cont or Odn or DG/US must be consulted and must be final on any action related to this Program. It is to be noted that the GO is already active in these areas and that no conflict of actions must develop. Note that SWOTS 17 to 23 are actually GO business but are tied into this Program and to be considered part of this program even though GI areas of action.
- 8. All targets must be activated as rapidly as possible except those which apply to the UN as the UN (and EU Commission) require all recourse to be exhausted before taking action.
- 9. When any of these projects bog, do a proper evaluation and debug them and get them going again.
- 10. Maintain total public and internal organization secrecy on all these projects and each one of them until one of them is completed with success and then only publicize that one without reference to any others.
- 11. That the plaintiffs in each case do not become liable themselves to damages.

# OPERATING TARGETS.

These targets are too lengthy and detailed for immediate summation on one sheet. Therefore they are designated SWOT 1 (Snow White Operating Target Number 1), SWOT 2, etc.

## PROGRAM CODE:

An innocuous CODE which can be used in telex and despetch form has been developed for use in this program. Each target is itself a Project. These are all of a family of names relating to the well known fairy tale "Snow White and the Seven Dwarfs" appropriate as an anti-person story carried out by secret means, as the villains in the case are spreading a fairy tale with no basis in fact. Associated names are Witch, Stepmother, Prince, Maiden, Skin, Lips, Blood, Magic, Mirror, Hunter, Lace (poisoned), Apple (poisoned), and the names Happy, Bashful, Doc, Sneezy, Grumpy, Sleepy, Dopey. There are other names in this fair; tale, Dance, Shoes, Revival, Sister, Animal, Heart, Mais, Pick, Shovel, Lantern, Ore, Tunnel, Car, Housekeeper, Broom, House. None of these words will be used for persons involved, enly for projects, with the overall name SNOW WHITE to cover this program.
