WHEREAS, The Church of Scientology of San Francisco is legally permitted to grant a Rental or Parsonage allowance to the ministers of this Church,


WHEREAS, Board of Directors approval is needed pursuant to the By-laws of this corporation,

WHEREAS, a recent survey of ministers shows a wide spectrum of rental amounts that ministers of this Church are entitled to as a Parsonage allowance per Internal Revenue Service Codes; these need to be calculated on an individual basis,

NOW, THEREFORE, BE IT RESOLVED: That the Board of Directors approves a change in amount for each individual minister as is applicable as a Parsonage allowance depending upon their individual expenditures,

NOW, THEREFORE, BE IT FURTHER RESOLVED: That each individual minister is responsible for reporting accurately his weekly expenditures for providing a home (rent and utilities) to the appropriate accounting personnel and to advise them immediately of any changes.

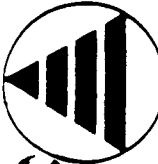
This consent is executed pursuant to the By-laws of this corporation which authorize the taking of action by unanimous written consent without a meeting. Executed this 13th day of November, 1984.
