If they are unable to do so, each party shall select a separate arbitrator, and the two arbitrators so selected shall choose a third arbitrator. Each arbitrator shall be in good standing with Dianetics Foundation International. Each arbitrator shall be familiar with the Hubbard Writings and in particular those Hubbard Writings pertaining to ethics and justice. The decision of the arbitrator or arbitrators shall be final.
