REVERSION AND RESERVATION AGREEMENT

This Agreement is made this 17 day of June,
1965, by and between:

RELIGIOUS TECHNOLOGY CENTER, a California non-profit religious corporation having a place of business at 6517 Sunset Boulevard, Los Angeles, California 90028 (hereinafter referred to as "RTC"); and

INSPECTOR GENERAL NETWORK, a California non-profit public benefit corporation having a place of business at 4251 Encanto Avenue, Los Angeles, California 90028 (hereinafter referred to as "IGN").

Recitals

WORLD INSTITUTE OF SCIENTOLOGY ENTERPRISES, INC., a Delaware corporation having places of business at 1340 North Berendo, Los Angeles, California 90028 and 34 North Fort Harrison Avenue, Clearwater, Florida (hereinafter referred to as "WISE") is the owner of certain trademarks and service marks pertaining to SCIENTOLOGY philosophy, DIANETICS technology and organizations related thereto, including numerous existing applications and registrations in various countries and the

right to file applications for registrations of unregistered marks in those countries, the trademarks and service marks including those that are listed in the attached Exhibit A (hereinafter referred to as "the Marks"), and the applications and registrations owned by WISE including those listed in the attached Exhibit B (hereinafter referred to as "the Applications and Registrations").

B. The rights of WISE as owner of the Marks and the Applications and Registrations are subject to a right held by RTC to require conveyance of the marks to any person designated by RTC.

C. RTC has designated IGN as the party to whom WISE is to convey the Marks and the Applications and Registrations, and WISE is entering into an ASSIGNMENT AGREEMENT with IGN concurrently with this Agreement (a copy of that Assignment Agreement being attached hereto as Exhibit C and hereinafter referred to as "the Assignment Agreement").

D. As a safeguard against danger to the Marks and the goodwill associated therewith, RTC has reserved, to itself

and its successors and assigns, a reversionary interest in the Marks and the associated goodwill, and IGN has agreed to the reservation of this interest by RTC as a condition upon IGN's ownership, on the following terms and conditions.

E. The rights of RTC and WISE with respect to the Marks are subject to a right reserved and retained by L. Ron Hubbard ("LRH"), as former owner of the Marks, to supply approved products and to license and contract with others to supply approved products bearing or embodying the Marks.

Agreement

1. The recitals are hereby made part of this Agreement and are acknowledged to be true.

2. In consideration of the rights granted to IGN in the Assignment Agreement, IGN hereby acknowledges and agrees that:

a. RTC has a reversionary interest in the Marks and the Applications and Registrations which shall vest in RTC if IGN, in the judgment of RTC or its successor or assign, fails to preserve and maintain the ethical use of the Marks in accordance with the writings and recorded spoken words of LRH, or in any way places the Marks in danger of appropriation by any entity that is outside or hostile to SCIENTOLOGY philosophy or DIANETICS technology, or permits use of the

Marks in any way that is contrary to the writings and recorded spoken words of LRH and seriously damages SCIENTOLOGY philosophy, DIANETICS technology or the image or repute of LRH; and

b. the rights of IGN with respect to the Marks are subject to the right reserved and retained by LRH to supply approved products and to license and contract with others to supply approved products bearing or embodying the Marks.

3. In the event that any of the conditions in Paragraph 2a. occurs, RTC or its successor or assign shall give written notice to IGN of such occurrence, and ownership of all of the Marks and the Applications and Registrations shall immediately vest in RTC or its successor or assign.

4. The rights of RTC under this agreement are assignable by RTC, and all rights of RTC regarding the Marks are subject to a pre-existing option held by Church of Spiritual Technology, a California non-profit corporation. IGN acknowledges that its rights are subject to the same option.
