2 Scientologists Blast Organized Psychiatry

Two Scientologists, one a psychiatrist the other a lawyer, unleashed a scathing attack on "institutional psychiatry" Saturday calling for an all-out war against "suppressive psychiatric abuse."

Both men drew thunderous applause and standing ovations from some 3.000 Scientology followers when they made their tirades during the controversial group's three-day annual convention in the Long Beach Arena.

AND THEIR exhortations were quickly transferred into action as scores of the L. Ron Hubbard disciples signed petitions after the talk demanding to know from former heavyweight champ, Joe Louis, whether he wishes to remain in the Colorado State Psychiatric Hospital.

The first speaker, Dr. Thomas S. Szasz, professor of psychiatry at the

State University of New York, expressed the hope that more people (as the Scientologists already do) will recognize that "the alliance between organized medicine and the American government is evil, not good.

"And more particularly that the alliance between organized psychiatry (or institutional psychiatry) and the American government has, under the guise of "treating mental illness" actually produced a political apparatus for creating and persecuting deviance."

DR. SZASZ outlined what he saw as the opposing forces in the field of mental health treatment.

On the one side are those who advocate everincreasing use of "psychiatric force and fraud," he said, by seeking to expand the concept of "mental ill-

ness" and using it to justify involuntary "treatment."

On the other are those who seek to restrict the concept of illness to "publicly demonstrable anatomical and physiological disorders of the body."

He summarized this as a struggle between "collectivism and individualism." He said he believes individualism is gaining in the battle, but warned:

"Individual dignity and freedom have their enemies — the most important among them, Communism in the East and Institutional Psychiatry in the West."

The petition signed by the Scientologists states: "We want to know: Where is Joe Louis? We want to hear from him, not his lawyer, his family or his psychiatrist." The group says it will present the petition to the head of the Colorado hospital Monday. The second speaker, John Joseph Matonis, a Washington attorney, drew

the audience to its feet when he introduced himself as the man "who sues suppressive psychiatrists."

MATONIS related a case in which he claimed a patient was held against his will in a mental hospital and submitted to excessive electro-therapy treatment because he had evidenced suicidal tendencies. He said the man, a Hungarian refugee who could not speak English, was ultimately freed on a court order and placed in a productive job by the group Matonis represents. the Citizens Commiteee on Human Rights.

After lashing out at numerous abuses which he says exist in mental hospitals he called for Scientologists to take up the fight by letting "the tortured beings in mental hospitals know you're there and fighting for them."

The group's convention ends today.

Scientologists' Convention **Ends on Cheer for Hubbard**

About 3,000 scientologists from across the nation wrapped up their threeday national convention in Long Beach Sunday with a rousing, two-minute standing salute to their "commodore and leader." L. Ron Hubbard.

The group had just heard a tape recorded message from Hubbard, made in the Mediterranean aboard the 3.000-ton motor yacht, Apollo, from which he runs the oft-controversial religion.

As his voice reverberated through the Long Beach Arena, spotlights played on a gigantic portrait of Hubbard, the onetime science fiction and screen writer who founded the religion 20 years ago.

When his message was finished the delgates rose to their feet, whistling, cheering, clapping in salute to the man in the 18 by 12 foot portrait above the stage.

Hubbard, in his message, bemoaned the ills besetting American society today — "the kids on the street; the fears people

have for their safety; youths turning to drugs; police unable to cope with the problems."

"Yet there is a way to stop our whole society from going downhill so rapidly," he said.

"If we took all those welfare funds and the money spent on war, we could really build the country up again.

welfare "The funds could be used for giving all those people jobs in-stead of America messing around in a war overseas. And the war funds could be used for reconstruction so that America can be what it was always intended to be - the greatest country in the world," he

He told his followers they could do something about the situation.

"Scientologists are in the upper tenth of the up-per tenth of the world's population in intelligence,"

he said.
"So don't just sit back get processing (undergoing training to achieve certain levels in the religion)," he said. "Get trained up and ready yourselves for doing something about the social

he Flying Nun. Mr. Malko, a freelance writer and film producer, tells us the whole inspiring story of L. Ron Hubbard, who rose from the lowly estate of a science-fiction novelist to become our first operating thetan. Mr. Hubbard operates these days from a fleet of ships somewhere in the Mediterranean, seeking his previous incarnations with the help of the \$140,000 a week he receives as his 10 per cent cut of Scientology's gross income. His "thetan" (beingness) has been liberated because he got rid of the one basic "engram" (the sound impression a psychic trauma makes on our protoplasm), which "was received by the human race many, many centuries ago, and probably was a supersonic shot in the forehead, chest and stomach, incapacitating, and reducing, the size and function of the pineal gland." Not to slight the "To For-get" goal planted on him at the Heistrobus station "some 38 trillion to 43 trillion years

Subscribers to Fantasy

I can't go on, Fortunately, Mr. Malko managed to do so, because 15 million people subscribe to Hubbard's fantasy. It's a church with a tax exemption, inside which the parishioners play games to free their theta bodies from their MEST (Matter-Energy-Space-Time) bodies. It offers a little bit of everything: Orientalia (reincarnapsychoanalysis (talking out one's aberrations); scientific authority (E-meters to measure one's anxiety, tone scales to chart one's progress); fantasies of omnipotence (a theta body will be capable of telepathy, psychokinesis, etc.); sci-fi ro-mance (all that galactic gallivanting, those goal-implanting stations on other planets); utopia ("total freedom"); and Descartes (the pineal gland makes a comeback!).

Does it do any harm? Mr. Malko is un-able to substantiate rumors of kidnapping and other forms of huggermugger. He does paint a frightening picture of the "Ethics Gestapo," a paramilitary corps of commis-ages who policed the laity's thinking during Great Amprinistics Heresy. There were legalty oaths, security checks, even a Chiminals Prosecution Bureau. Those deviating from the Hubbard line were to be levestigated for any crimes in their past if crimes were found, they were reported to the police, Since each Scientology convert goes through "auditing" and E-meter sessions, which open up a lot of leads for such an investigation, it was as though a Freudian analyst turned over his private files to the police when a patient decided to switch to Adler to Jung

Remember That Gorilla?

However ugly these proceedings, and vever suspect the disordered ravings of Hubbard against his real and fancied enemies, no one appears to have been permanently hurt. And when a Scientologist tells you that, while thinking about the reasons why he had a toothache, he suddenly saw a gorilla-gorilla goals having been implanted in his theta 83 trillion trillion trillion years ago—and the pain disappeared, what can you say? If he thinks it works, maybe it works, like New Criticism, glue-sniffing, astrology, yarrow stalks and bubblegum.

Mr. Maiko runs it all through the sausage machine-Hubbard's unacknowledged debt to Dr. A. Nordenholz and R. McMaster Accuses Hubbard of Fostering Spiritual Tyranny Within Organization

One year ago an articulate but soft-spoken man named John McMaster was extolling the virtues of Scientology and L. Ron llubbard, the founder of the worldwide, quasi-scientific "religion."

Appearing on television talk shows and giving lectures as Hubbard's personal representative, McMaster was eminently qualified. He was the first person to achieve Scientology's state of "clear," which purportedly gives a person full control of his mental processes.

Now McMaster describes the Church of Scientology and other organizations run by Hubbard as engaging in "spiritual tyranny."

"Ron was always busy getting everybody looking beyond the mulberry bush for a nonexistent enemy," said McMaster in a recent interview.

Discipline Group

The 43-year-old South African was in Los Angeles for the first time since he resigned last November from Scientology's Sea Organization.

Scientology was an outgrowth of a book, "Dianetics," published in 1950 and written by Hubbard, a on etime science - fiction writer and Hollywood screenwriter.

For more than a decade, working from a yacht in the Mediterranean, Hubbard has elaborated on psychoanalytic techniques with the "E-meter," similar to a lie detector, and the courses offering "the road to total freedom."

The Scientology organizations have had run-ins with the Food and Drug Administration and Inter-

nal revenue Service in this country and with some government agencies in other countries. However, Scientology officials claim that they have been falsely misrepresented by some disenchanted followers, government officials and the news media.

London Suburb

World headquarters is in a London suburb, but a large following exists in the United States, particularly in Los Angeles where the American Saint Hill Organization, 2723 W. Temple St., represents the only advance-course center for Scientology in this country.

McMaster said he resigned because of "unnecessary harshness" in the organization "that kept people in a kind of electronic jitter." He said he also opposed his reassignment from a public relations nission to the United Nations to service aboard one of the Sea Organization's several yachts.

Mc Master, still convinced of the value of Scientology's teachings and analytic techniques, recently gave some lectures in Phoenix and the Los Angeles area on behalf of a Dianology organization in Westwood run by Jack Horner, another ex-Scientologist.

Lecture sponsors in Phoenix, McMaster said, were told by Scientologists that "a different spirit was occupying the body of John McMaster." McMaster said he had heard that explanation used be-

fore in Scientology to explain the changed attitudes of some persons.

A spokesman from the Church of Scientology, 2005 W. 9th St., denied that the church has said that of McMaster.

Regarding the circumstances of McMaster's resignation, the spokesman said reports had been made by Scientologists last year that McMaster was "holding the founder in contempt in public," was becoming money-motivated and was accused of conduct unbecoming a minister of the church.

"We started making every attempt to get him to undergo spiritual rehabili-

tation, but these attempts were thwarted," said the spokesman. A telegram was sent recalling Mc-Master for rest and spiritual counseling, but no reply was made, said the official

Later Expelled

"At that point he left and went into hiding and tendered his resignation, but not through proper authorities," said the spokesman. For McMaster's "betrayal of trust" and other acts, he was later expelled

McMaster left New York by freighter to his home in Durban, South Africa, but only after expressing the hope for some rapprochement with Hubbard.

While in Durban Mc-Master said he was approached by Scientologists who offered to give him some "Class A auditing (interviewing)" free of charge. "I accepted it as a peace offering but I asked my mother to come with me," said McMaster.

"It wasn't auditing. It was a security check—they were trying to find some crime I'd committed," McMaster said.

'Closed Book'

"At this stage, they left me and I realized that Scientology was a closed book for me," he said. McMaster said he has

McMaster said he has not denounced the techniques of Dianetics and Scientology "and never will." But the organization in charge has "built a structure and called it God," he said.

McMaster in February, 1966 became the first of thousands to achieve "clear" status.

If McMaster disagreed with the practices in Scientology, why didn't he quit sooner? "I felt that as long as I could get out and deliver the sane truth, this would show that all this ethics stuff (internal security) was perfectly unnecessary," he said. "It didn't work," he said.

Girls in This Man's Navy

The caller to the newspaper identified himself as a Long Beach resident who visits the harbor frequently.

"There's a ship out here at Berth 10 with a bunch of kids on it," he burst out. "Cute girls on it, too... and they claim to be members of the crew."

Catching his breath, the caller went on. "I'm not knocking any of it, but when I asked what kind of ship it was the crew members said 'a training ship."

"All I've got to say is that's one hell of a navy. Where do I sign up?"

WHAT HE had under surveillance was the converted submarine chaser Bolivar, now a floating school for 44 young followers of Scientology — the somewhat controversial religion described as "the first fully precision science of the mind."

Members of the Bolivar crew work together during a lengthy excursion and learn to be executives within the Sea Org (organization), the major branch of the Church of Scientology. The Sea Org bought the Bolivar a month ago.

The church, founded by former science fiction writer L. Ron Hubbard, has attracted a large following throughout the United States and portions of other countries.

Last July 3, approximately 3,000 Scientologists gathered at the Long Beach Arena for a threeday annual convention which marked the religion's 20th national celebration of the theories of dianetics and "total freedom."

Gregory Schiller. 22, the Hubbard representative on the Bolivar, had turned down a full-paid scholarship to Reed College in Portland. Ore., to follow the religion that attempts to deal with a human being as an intricate mechanism.

The recently named minister of Scientology said, "We believe in self-determinism as being the common denominator of all life impulses."

The Bolivar, said Schiller, "is a sort of intro-organization management training service. It was set up to forward the research of L. Ron Hubbard and it offers courses in dianetics—laws of the mind."

Schiller, polite and softspoken in a way that supports his claim of "inner peace," displayed some of the textbooks for the seafaring school.

Reproduced diagrams and explanations of boating, using the practice of dianetics, comprise the written lessons for the course. The rest of the curriculum consists of discussion, "asking why about anything whenever you need to know." and introspection.

Schiller and his crew, who will be here one more week, are hard-working youths, 18 to 25, who live together "with love and understanding of the world around us."

The Bolivar's "one hell of a navy" is putting its religion into practical use—survival at sea—in what Schiller calls "a simple matter of putting your philosophy where your mouth is."




